The newly formed Lakeland School System wants community input for its decision-making process and is seeking your help.

To assist the new Board and superintendent, complete their brief survey by either scanning the QR code (to the right) with your phone or going to the SurveyMonkey link: <https://www.surveymonkey.com/s/lakelandk12survey>.

Included in the 10-question survey are queries as to whether you have children in Lakeland-area schools, goals for the LSS, five priorities in starting the system, do you want school uniforms and in what form you would like to receive future information about LSS. There is also an area for your thoughts and comments.

The questionnaire was coordinated by Board member Matt Wright.

Hard copy versions of the questionnaire are available at Lakeland City Hall.

In commenting on the study, Dr. Ted Horrell, superintendent, said, "One of the most exciting things about a smaller school system is the opportunity to really use community feedback in our decision-making process. The school board and I feel like it is important to have both formal and informal ways for Lakeland citizens to give input into the priorities and goals of the Lakeland School System.

"We understand that we won't always find unanimous support for the decisions we make, but we can be sure we have made those decisions thoughtfully and with input from the community.

"While there are a lot of decisions to be made in a short amount of time, we want to be sure we are not making those decisions in a vacuum. In only my second week on the job as superintendent, I've been so encouraged by the level of excitement and engagement I'm seeing in parents, teachers, administrators and other stakeholders in our new system."

Much Ado in Lakeland City

Activity has been continuous at Lakeland City Hall in recent weeks with both city government and municipal school news.

- ✓ Kevin Floyd was elected chair of the Lakeland School System Board, with Laura Harrison as co-chair.
- ✓ Wyatt Bunker, mayor, submitted his resignation to the Shelby County Commission effective last month for his district 4 seat on the Shelby County Commission. His remaining term was less than a year. Mark Billingsley, former Germantown alderman, was appointed Jan. 13 to fill the vacancy.
- ✓ Chris Thomas was selected as the new city manager & continues his position on the Shelby County Commission, district 4, until August. (p. 2)
- ✓ Dr. Ted Horrell from Germantown was named the first superintendent for Lakeland School System. (p. 2)
- ✓ Plans are being formulated to locate the school system offices in the old City Hall area. (p. 5)
- ✓ There will be a joint meeting of the BOC and Lakeland School Board Feb. 22 so all members can share goals and work as a team.
- ✓ The contract with Republic Services (trash & waste) will not be renewed in July, a vote unanimously approved by the BOC. Bids will be sought from other companies in the interim.
- ✓ Matt Wright was elected to represent LSS with the Tennessee Legislative Network, a liaison between school boards and the legislature.
- ✓ City Hall flooded the weekend of Jan. 11 after a water heater explosion. (p. 5)
- ✓ Lakeland competes for most active city in Tennessee. (p. 2)

New City Manager

From a field of nine candidates, four appeared for city manager interviews Dec. 17. Chris was selected unanimously for the job. During the questioning process he said he spent six years in private business and became the probate court clerk when he was 29 years old. He has also served on the Memphis City School Board and will continue as a Shelby County Commissioner until his term expires in August. "I was a hard worker, got out front with my employees and I knew where to find the answers."

He said he would meet regularly with employees, plus the mayor, commission and the public. "I have an open door policy." He is a lifelong Shelby County resident and has relationships in the community with local, state and federal officials. He wants Lakeland to be a destination for families and businesses. Although Lakeland residency was not a requirement to apply for the job, Mayor Wyatt Bunker asked each candidate if he would be willing to move to Lakeland. Chris said he currently lives in Bartlett but wants to move to Lakeland.

His salary approved by the Board of Commissioners is \$85,000 plus benefits.

He is a graduate of Kingsbury High School and the father of three. He holds a degree in marketing from the University of Memphis and is an active member of Faith Baptist Church in Bartlett. His community involvement includes the St. Jude Golf Classic, Delta Fair and Music Festival and Memphis Mid-South Race for the Cure.

LSS School Superintendent

The newly hired superintendent, Dr. Ted Horrell, became principal of Germantown High in 2011 and before that was principal at Millington Central where he requested and oversaw the initial stages of a \$5 million expansion of the high school facility. He also has been a vice principal at Bartlett High and assistant principal at Germantown High 2006-2007. Dr. Horrell wrote the school's successful application to be named one of "America's Best High Schools" in Newsweek magazine.

He taught English for two years in Nagoya, Japan, at Aeon Intercultural until 1998. When he returned to the states, Horrell was a film and video/communication arts instructor at Germantown High.

He has a bachelor of journalism degree from the University of Missouri and Master of Science and Doctor of Education degrees from the University of Memphis. He is an active member of Germantown United Methodist Church and has been a volunteer with the Community Alliance for the Homeless and served in leadership roles in Millington.

He was selected from a field of four candidates Dec. 23 and unanimously approved by the Board.

During the interview process with the School Board Dec. 20, he said the biggest challenge is to get the momentum to move this system into the future, to make the dream a reality. "I think this is an amazing opportunity to take a system like this, with one school and build a model for the state and the nation," said Dr. Horrell. His three and one-half year contract with the Lakeland School Board was approved Jan. 6 for \$132,600 annually plus insurance and car and phone allowances.

New Local Business in the Southland Log Homes Building

The familiar log house facing I-40 is now home to a Lakeland law practice, owned by Lakeland couple Lori and Bradley Ball of Cool Springs.

Bradley said they are using most of the space in the building at 9665 Village Circle Drive for their firm called Mortar Bar LLP, from his days with the Air Force in Iraq. "When I served as a counterintelligence officer, the contingent of Australian soldiers opened a "Mortar Bar." There was no alcohol; there were frequent mortar attacks. It was a popular gathering spot to exchange stories amid the chaos of Iraq at that time. We do a lot of things different than traditional law firms and I sought a name that both reflected our military connection and break from legal tradition," he noted.

As the founding attorney, Bradley said they have two lawyers and expect to have two more by April. They handle family law and criminal defense matters plus represent injury claims. "We require special training for everyone on our team to better handle matters involving military members. The military has its own lingo and unique legal situations that most attorneys are not prepared to handle. He and Lori have three sons, Christian, 18 at AHS and will go to University of Colorado-Boulder in the fall; Garrett, 12, AMS; and Oliver, 8, LES. Bradley grew up in Lakeland and attended the U.S. Air Force Academy and University of Memphis law school. In addition to his private practice, he serves as a JAG in the Tennessee Air National Guard.

Southland will continue to operate out of the "annex" with a salesman on site most of the week, according to Bradley.

New Fitness Facility for Lakeland

Construction of LA Fitness in Lakeland has been approved by the City and could be started in the next 90 days and open this year.

Don Barber, chairman of the Municipal Planning Commission, said, "LA Fitness was approved 4-0 by the DRC (Design Review Committee) and 5-0 by the MPC (Municipal Planning Committee) with no changes to the second draft of the city's suggested conditions, except that overall exterior lighting levels will come into compliance with the regulations. "If approved by the BOC, construction of LA Fitness in Lakeland could be complete late this year."

J. Higbee, growth management director for Lakeland, noted LA Fitness does have to do a development contract with the Board of Commissioners before they can start construction.

The southern California-based company will be on Highway 64 at I-40 on an almost five-acre site facing Highway 64 and slightly visible from the interstate. The fitness facility will have 41,000 square feet, with 37,840 square feet on the lower level.

The developer for the project, Colby O. Fincham with Barclay Group in Phoenix, AZ, said site work could possibly begin in 90 days pending approval and permits. The plans submitted to Lakeland indicate the facility will include a lap pool, basketball and racquetball courts.

Other offerings typical at LA Fitness include state-of-the-art equipment and cardio area, group fitness classes and specialty classes such as yoga, cycling and Pilates.

Annexation a Possibility into Lakeland?

Neighbors in unincorporated northeast Shelby County are discussing the possibility of becoming part of Lakeland and are gathering necessary names for a petition.

Chris Thomas, city manager, said, "We have been approached by citizens telling us they are interested in us annexing them. Once they present petitions to us, we will look into the cost of services and time frame."

The area to be considered for annexation into Lakeland is in the vicinity of Bolton High School, 7323 Brunswick Road, and Barret's Chapel School, 10280 Godwin Rd.

In addition to Mayor Bunker, others invited to the February meeting include Dr. Ted Horrell, superintendent for the new Lakeland School System, Chris Thomas, Lakeland city manager, members of the Board of Commissioners and members of the LSS School Board.

Partnership Lakeland is a citizen's political action committee comprised of local residents dedicated to recruiting and electing the most qualified candidates to run for local office. PL was formed in March 1999 and is registered with the State of Tennessee and the Shelby County Election Commission as a Political Action Committee.

Fifteen years ago, a group of concerned citizens believed the welfare of the city was not adequately being addressed and, representing every subdivision that existed in 1999, began weekly meetings. From this group, PL emerged and set a model outline for a political platform. The hope was that each candidate would use it to construct their individual platforms.

The goal of the organization became promoting and supporting qualified candidates with integrity who were running for Lakeland offices. PL encouraged candidates to represent all citizens and respond to community issues within the framework of the city manager-commissioner form of government.

Partnership Lakeland does not accept donations from outside sources and depends upon membership dues and donations to fund its efforts. The bylaws preclude accepting contributions from other political action committees, political parties, trade associations and corporate entities.

"Our membership in Partnership Lakeland has enabled us to become acquainted with so many of our fellow citizens, elected officials and volunteers. It has given us a true sense of community," said Mitzi and Phil Pilcher who are both members of PL and officers of the group.



School Board Offices

At the Jan. 6 work session of the School Board, Chris Thomas announced that Mayor Wyatt Bunker suggested the School Board locate offices in an underutilized area of City Hall. The space could be renovated in a couple of months and both entities could share common areas. He noted that he wants the space to be first class for the staff, parents and citizens coming to the school offices. The School Board voted Jan. 13 to move forward with that plan.

Flood at City Hall

The City has been dealing with the aftereffects of a water heater explosion over the Jan. 11 weekend, according to Chris Thomas, city manager.

Every baseboard within range of the water will have to be replaced as well as most of the carpeted areas. The damages are currently estimated at \$50,000 which insurance will cover.

Chris said, "I am grateful for the hard work of City employees through the crisis. We want to thank our neighboring government agencies, including the cities of Bartlett and Germantown and the Shelby County government for allowing use of their fans to minimize damage costs."


