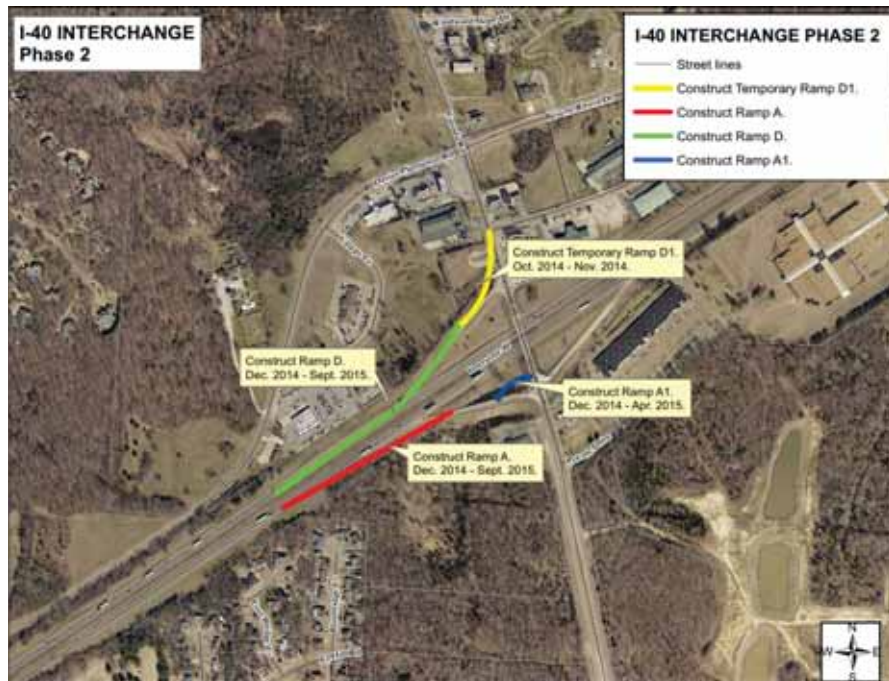

Business, Interstate Activity in Lakeland

The phase 2 map of I-40 construction on page 2 shows progress is on schedule, according to Jim Atkinson, director of city planning and administration. The connector to Huff N Puff from Beverle Rivera Drive should be complete early next year. The phase 2 rendering shows ramp work through September 2015.

Jim said the LA Fitness building on Highway 64 is evolving and should be open the end of this year. The Irvine, California-based fitness center is to be 40,000 square feet with an indoor pool for lap swimming and classes. The business started in 1984 and today has state-of-the-art clubs across the continent. It is visible from both I-40 and Highway 64.

Sprouts Farmers Market was announced to fill 60 percent of the former Kroger Store in Lakeland in the Country Bridge Shopping Center. Target opening date is spring 2015. Another tenant is under consideration for the remainder of the store space. Kroger was shuttered after Schnucks moved from Memphis in September 2011 and Kroger bought its grocery stores. The re-development of this shopping center will provide much-needed tax revenue since Kroger left Lakeland creating a \$300,000 sales-tax deficit, according to Chris Thomas, city manager. Conservative sales tax estimates for the new Sprouts store are expected to be \$300,000 a year.

At the former Factory Outlet Mall, the name of the shopping area will be "Lake District" instead of "Grand Outlets," according to Jim. Details forthcoming.

Delta Blues Winery and Vineyard, 6495 Stewart Rd, is to open later this fall according to Dianne Day, one of the partners in the business. The new Lakeland business is on 15 acres at Paul Barrett Parkway.

Special Census - starts Nov. 1

Chris Thomas, city manager, announced there will be a special census for Lakeland. It is estimated there are 750 more residents than during the 2010 census. That equates to \$110 per resident or an additional \$82,000 per year in revenue for the City. Snail mail letters are to be sent to residents Nov. 1 with follow up door-to-door canvassing in January. The next full census is in 2020.

Lakeland residents can dispose of hard to get rid of items this fall. You must be a City resident to participate and provide a drivers license or current MLGW bill. No exceptions.

The following will be accepted:

Bulky trash, e-waste (TVs, monitors, computers, printers, cell phones, and cell phone batteries), white goods (washers, dryers, small household appliances), tires (limit four, no rims), scrap metals, construction debris (residential) and yard waste.

Republic Services and Cyber Yard will provide dumpsters and receptacles for your discards to be recycled and properly disposed.

We will not be accepting household garbage or these hazardous wastes: Oils, paints, antifreeze, pesticides, herbicides, chemicals, railroad ties, fluorescent bulbs, light bulbs, alkaline batteries or refrigerants (A/Cs or refrigerators).

These items can be taken to the Memphis and Shelby County Hazardous Waste Facility at Shelby Farms, 576-6851.

Due to EPA rules, we cannot accept any appliances with refrigerant in them.

Before disposing any items in the trash, please consider donating useable items to the Salvation Army, Goodwill Industries, Disabled Veterans or other charitable organizations.

Leaf Collection Program

The City will begin collecting loose leaves from each resident's curb by a vacuum truck Nov. 17. Leaves must be on a resident's property, no more than five feet from the street. Never rake leaves into the street, as they can be washed into the storm sewer. Do not pile leaves around mailboxes and signposts. Place in an open area. The crew will not pick up leaves under, between or around parked cars. If the vehicle is not moved, the leaves will remain until the next pick up time. Contractors/lawn care professionals must haul away their own waste. Do not put grass, tree branches or brush with leaves. NO BAGS ALLOWED. LEF Awards First Teacher Grants

On October 16 the Lakeland Education Foundation launched its first annual LES Teachers Grant Awards night at Lakeland Elementary School. "This was a follow through on our commitment to our teachers and parents to provide as much money as possible to programs that will enhance the curriculum," said Cecil Tompkins, Foundation president.

Twenty-seven teachers applied for the grants. To be considered, each teacher who applied was required to submit a detailed application describing the reason for the grant money, the details of the program or project they wanted funded, and the expected impact on LES students. Some of the grants that were awarded covered more than single classrooms and, in some cases, covered several hundred students. A special grant was given to the school for some computer lab upgrades. The total value of the grants exceeded \$17,000.

Teachers receiving grants: kindergarten - Lorna Miller, Gail Stephens, Lori Welch, Jill Baker, Michelle Filsinger, Krista Bruce and Beth Bagley; second grade - Sandra Norvell; third grade - Arzu Booth, Christy Papon, Christy Estes, Teri Hoffman, Kim Hallum and Renee Pirkey; fourth grade - Stacey Hume and Allie Garza; fifth grade - Joanne Switzer; K-1 Lisa McDaniel; K-2 Johnna Herbison and Brandy Ortiz.

Teacher grants have been the primary focus of Foundation Board members this school year, as they continue to build community and corporate support for the Lakeland School System.

In a historic vote this month, the BOC approved a tax ordinance that will increase the current property tax by 55 cents and be used for a grades 6-12 school facility.

The original ordinance was amended to note the special property tax will "assist in funding the construction of additional school buildings," according to the official document. It further reads that the new tax is established solely for the retirement of the anticipated school bond debt, shall take effect July 1, 2015 and be collected for the year 2015. The 55-cent tax will terminate when the school bond debt is retired.

The move was controversial with Lakeland residents spending the summer and early fall voicing their opinions on social media about the need for a tax increase, a proposed \$50 million bond issue and ultimately a new school building.

During a lengthy public hearing Oct. 14, sixteen citizens spoke to commissioners. Equal numbers (eight) were in favor of the tax and proposed bond issue and eight against. Some proponents arrived with signs, "Yes to Prep and Prosperity" and wore yellow T-shirts that said, "We believe in the children and our future." Applause was abundant for both sides. Those critical of the move cited arguments heard over the past few months: "Why the rush? How can Lakeland afford such a big debt? It will be devastating to seniors on fixed incomes." Those in favor of building a school building sooner than later cited the impact on property values and the need for families to know where their children will attend school K-12.

Commissioner Randy Nicholson squelched internet rumors that he is selling his Lakeland house to avoid paying a tax increase. "I was appalled that Facebook had assumed that," he said. "It has nothing to do with that. I made the decision at Thanksgiving last year to put my house on the market because my wife wants to move closer to our two baby grandchildren." He said he has served Lakeland 19 years and public officials do the best they can with what they have. "This Board tries to follow the will of the citizens."

The Lakeland School Board will now get to work, according to City Attorney Chris Patterson. "They will hire a consultant and project manager to oversee and assist with site selection," he said. The new \$1.40 tax rate will be in the budget for the 2015 year, he added. After that, the City will begin the bond process with a consultant and counsel.

In an effort to be transparent about the proposed "Lakeland Prep" 6-12 school and its funding, both the BOC and Lakeland School Board offered nine public meetings plus regular BOC and LSB sessions for citizen discussion. In addition to complaints about the higher tax rate, some voiced concern that Lakeland effectively has a higher rate because of fire and ambulance fees currently on the Memphis Light, Gas and Water bill. Mayor Wyatt Bunker addressed that concern by noting there is work underway to bring fire service either "in house" or share with Arlington.

In other news at the October regular meeting, four new members were named to the newly formed Lakeland Development Corporation: Jeremy Clark, Abed "Victor" Ghosheh, Joseph Laster and Ronald Purifoy. They join three founding members, Terri Smith-Anderson, Paul Criss and Josh Roman, who will have six-year terms. Jeremy and Ronald will serve four years; Victor and Joseph, two years.

The City established an industrial development board to replace the Economic Development Commission. The LDC promotes and actively pursues economic development activity within the city. The LDC has a series of tools including the ability to create tax increment financing districts (TIF), tax abatements, and other methods of spurring re-development of existing areas and bringing new, high-quality commercial development to Lakeland.

In other BOC business this summer and fall:

➤ Ginny Dunn, economic development coordinator for the Lakeland Chamber of Commerce, proposed a Lakeland Shop Local Holiday Program from Dec. 1 to Jan. 5, 2015. To promote local shopping during the holiday season and create a festive atmosphere, businesses can display additional signage, displays, and decorations beyond the current the city ordinances. Best displays will win an award and free waiver of one permit fee for the following year. The overall best winner will receive an award, free waiver of one permit fee for the following year and a cash prize.

➤ Andy Reynolds with A2H addressed the plantings on the medians on Canada Road. He said the plan was created in 2007 as a naturalistic area, not traditional, with a natural look of perennials, wildflowers, trees and shrubs. It featured drip irrigation. There was a lot of negative talk about the area and eventually it was neglected. Sherri asked what it might cost to fix the sprinklers and upgrade the area? \$10,000? He said he didn't know but would check on a price. At a later meeting, commissioners were given a new design of the medians but there was still confusion on what work would be done at what cost. The majority of commissioners seem inclined to repair sprinklers on the end caps of the medians and cap off other sprinkler lines for repair at a later date.

➤ The first ever Christmas tree lighting at Lakeland Elementary School will be Dec. 2. Brenda Lockhart, interim parks director, is coordinating with Commissioner Clark Plunk.

➤ Complaints have decreased about trash service and recycling although residents continue to have issues with the service, particularly limb and leaf pickup. Several commissioners said they didn't realize when voting on the new contract with Republic that services would be compromised. There is a two-bag limit on trash or yard waste along with the containers and anything over those amounts are charged at \$2 per bag. In the first three weeks of the new contract, there were 270 complaints, which dropped to 150 complaints in the four-week period of August. Wyatt said the contract cost this year is \$16 per resident versus \$23 on the old contract. "We are going to ride it out for a year," he said. "We knew there would be a spike of complaints. But this is a substantial discount and we will build up money in that account. Maybe we will reduce the cost to residents next year." Republic representatives said this month they are visiting Lakeland neighborhoods, knocking on doors and educating citizens on the new program. Residents are encouraged to bag trash and recycling, particularly glass, as there is less tendency for it to blow or scatter when transferred from the can to the truck.

➤ David Lenoir, Shelby County Trustee, gave his state of Lakeland report to the commissioners. For the 2013 tax year, 97.7% of Lakeland residents paid their property taxes, a higher percentage than the county average; there are 180 delinquent parcels to be collected and Lakeland has a 99% collection rate. In August of 2014 there were 21 existing home sales compared to 18 a year ago; no new home sales compared to two a year ago; and the median sales price was \$210,000 compared to \$234,000 a year ago.

➤ There are two new developments planned: Evergreen residential area with 139 lots at Evergreen and Old Brownsville Road; and Evergreen Square, at Evergreen and Highway 70, combined retail, assisted living, office, dementia care and possibly senior homes. These projects could be on the drawing board in a year according to Jim Atkinson, director of city planning and administration. Two ongoing subdivision developments were discussed. Kensington Manor amendments were approved with 20% maximum siding, elimination of a community pool and closing Evergreen Road at Highway 70. The additional development at Heron's Ridge was approved. In Kensington there is an impasse regarding a sewer line across Highway 70 via commercial property. The owner has not agreed to a price for the easement and Jim recommended the City pass a resolution allowing for an appraisal of the potential easement. This sewer issue involves not only the Kensington neighborhood, but others south of Memphis-Arlington Road.

➤ The City has hired Kim Odom as its first Senior Center part-time manager with the Center now open Monday through Friday.

➤ A representative of the West Tennessee Veterans' Home told of the need to build a skilled nursing rehabilitation center for veterans in the tri-county area. She said there are 3,000 veterans in Lakeland and challenged the City to budget \$100 toward the facility for each of the local veterans. Commissioner Gene Torrey commented he'd like to see the center in Lakeland.

➤ Melissa Bast from Light 'Em Up Fireworks shared with commissioners that the state attorney general has written an opinion that it is permissible for Lakeland to have more than one retail fireworks business. She is interested in buying commercial property in Lakeland for her business. She also said she would sell Duck Commander fireworks if she could locate in the City.

➤ After months of discussion, the Lakeland employee handbook revisions should be available to commissioners at the November meeting. Particular issues are short and long term disability and the amount of sick leave for part time employees.

Survey Offers Opinions on Lakeland Issues

A September survey conducted on NextDoor.com revealed varied opinions on crime, Lakeland Prep and the proposed property tax increase.

Wesley Wright, editorial board member for Lakeland Currents and vice-chair for COLA, commissioned the survey to satisfy his curiosity, provide civic responsibility and to gauge where Lakeland residents stand on relevant topics. The 13 questions were available on the social media site and yielded responses from 365 people of almost 1,100 registered users on the site. The survey link was posted on Facebook pages and received 77 responses of which 30 were not NextDoor users.

The first question asked if residents were aware of monthly crime reports indicating crime is increasing in the Lakeland area. Fifty-one percent said yes and 49 percent said no.

The second question asked if measures should be taken to help with safety and fight crime. Fifty-nine percent said yes, and 41 percent said no. Of the yes responses, suggestions offered included hire security patrols, install surveillance, start neighborhood watch, install gates or street lights and have informative meetings. The no responses asked who would fund the extra safety measures.

Participants were asked to identify their neighborhoods with 19 percent living in Plantation Hills, 12 percent in The Grove, 11 percent in Oakwood, 10 percent Windward Slopes, 9 percent Cool Springs, 7 percent Lakeland Estates, 6 percent Stonebridge and Woodland Park, 5 percent Woodbridge and Evergreen Hills.

When asked if respondents knew about Lakeland Prep (the proposed grades 6-12 school for Lakeland), 59 percent answered yes and 41 percent said no. When this survey was posted on Facebook pages, 72 percent answered yes and 28 percent responded no.

Answering whether there is support for the mayor, board of commissioners, school superintendent, school board and want Lakeland Prep, 52 percent said yes, 48 percent no. When the question was rephrased with more answer choices, 32 percent were undecided, 50 percent yes and 18 percent no.

Responses to "Why do you support Lakeland Prep?" included good for Lakeland, good for property values, it will draw families and businesses.

Those who answered they do not favor Lakeland Prep cited a dislike for the tax (proposed 55-cent property tax increase), disagreement with the school plans, too much debt for the City and why the rush.

Activities in the City were also a topic, asking what events should the Parks Board or any other board or Lakeland organization try to keep or bring back? Seasonal activities were mentioned along with creating a town center for the City.

LSB update (Lakeland School Board)

Since taking office in January, the five-member Lakeland School Board (LSB) has worked tirelessly to open Lakeland Elementary School on time and without flaws. This month their goals were to bring all Lakeland students to classrooms within the City limits and review the education standards from the Tennessee Department of Education.

In August Dr. Ted Horrell, superintendent, presented the Capital Improvement Plan (CIP) for the Lakeland School System (LSS) to the Board of Commissioners (BOC). It requested \$50 million to build a single facility for Lakeland middle and high school students. The BOC accepted the request and a special funding resolution, brought forward by Commissioner Gene Torrey, called for an increase of 55 cents per hundred dollars of evaluation to fund the new facility, fields, furniture and fixtures. The monies raised would be used solely for this one school facility. The collection of the special property tax would be eliminated upon the full retirement of the bond issued to build the school.

At a public forum on Aug. 19 Ted documented the needs and reasons for the combination middle/high school facility. Public Financing Management (PFM), a municipal bond consulting firm, demonstrated how the bond would be structured and repaid utilizing existing capital improvement funds and the new monies raised by the special property tax. Those who spoke at the forum were nearly unanimous in support of Lakeland Schools but some voiced opposition to the timing and amount of the property tax. In an effort to make sure that Lakeland citizens understood the issue, the LSB and BOC had nine meetings in August. At each of these meetings it was explained that Arlington Middle School is close to capacity right now; that it takes three to four years to build a new school; that not having K-12 schools limits Lakeland's residential growth, which in turn slows businesses growth.

The BOC agreed with the LSB that there would be no better time to finance and build than right now. By waiting two, three or four years Lakeland would only pay more for land, building materials and interest and this would require an increase in property taxes by more than 55 cents currently needed.

On Oct. 14 the Board of Commissioners passed an ordinance to create a special property tax. See details in page 4 story.

LSB also made a strong statement of their own. On Oct. 13 the Board unanimously passed a resolution regarding the current state education standards known as Common Core. The resolution written by Kevin Floyd, LSB chairman, and Ted puts Gov. Bill Haslam, the State Legislature and the Tennessee Department of Education on notice that LSB supports the development of a new education standard for Tennessee's students and they ask for a repeal of the state's adoption of the Common Core State Standard, originally adopted in 2010.



NOW THEREFORE, BE IT RESOLVED by the Board of Education of the Lakeland School System, Lakeland, Tennessee that the Lakeland School System Board of Education strongly encourages the Governor of Tennessee, the Tennessee Legislature, and the Tennessee Department of Education to repeal Tennessee's adoption of the Common Core State Standards in favor of new, rigorous standards and assessments created for Tennessee students to be developed with the input of Tennessee educators, school boards, and community members.

Crime Report for Lakeland - SCSO

For July 2014, there were 37 incidents versus 16 for June. The biggest increase was 19 vandalism misdemeanor/felony incidents from four the previous month. There were slight increases in aggravated assault (0 to 1); burglary/business (1 to 3); larceny other (2 to 4); theft from building (1 to 3); theft from vehicle (3 to 5). Crime categories of burglary/other, burglary/residential, motor vehicle theft/all, robbery/individual either stayed the same or decreased.

It is believed a group of teenagers (aged 16-18) are responsible for a lot of the vandalism. There were seven or eight cases of vandalism at the same time in Arlington. With a closer watch on the areas and students back in school, it is expected this crime will decrease.

Commenting on the July home invasion at East Shores, Lt. Terry Lomax said the victim was visiting from out of town and was babysitting her younger niece. She was in the kitchen when the suspect came through a back door into the kitchen and pushed the victim down. The suspect put a knife to her leg and told her he'd be back. There was no assault, but, "We get alarmed when we see that kind of thing," said Lt. Lomax.

In September, there were 11 incidents including a theft at the "under construction" LA Fitness on Highway 64. Three industrial welders were taken following a heavy rainstorm when workers left the site quickly because of the weather. The 11 compares to 10 incidents in August. Increases were noted in motor vehicle theft, larceny and theft from vehicles. Other categories remained the same or decreased. More crime was reported between 10 p.m. and 2 a.m.

Concerning the restroom wall threat at Arlington High School, revealed Sept. 21 on social media, Lt. Lomax said a person of interest was identified and interviewed. Later that week a 17-year-old suspect was arrested and charged with false reports, according to the SCSO.

Often they have wine tastings at their homes for frequent buyers. And they continue public wine tastings at the store from 5 to 7 p.m. Fridays. Going into fall and the end of the year, he said the store will carry seasonal items for holiday gifts and New Years Eve.

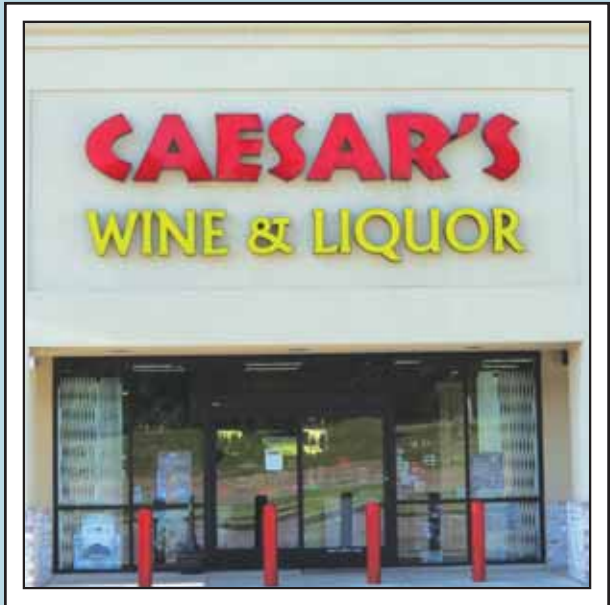
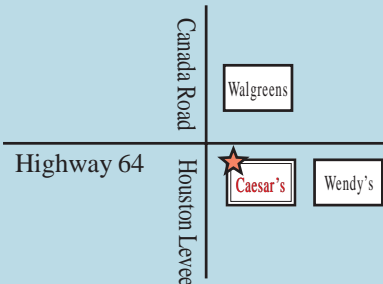
